The International Chamber of Commerce (ICC) is the voice of the private sector within the UN, WTO, OECD, G20 and other international organisations. Its mission is to make business work for everyone, everyday, everywhere.

Founded in 1919, ICC is the world business organization. Its members are organized in national committees.

With independent institutions such as the International Court of Arbitration, the Commercial Crime Service as well as by providing guidelines, which promote self-regulation (e.g. Incoterms®) and a vast number of publications on setting rules and standards in international trade, ICC supports the international trading system and facilitates the activities of companies.

ICC Switzerland is the voice of Swiss business in the International Chamber of Commerce, where it represents the interests of its member companies and organizations based in Switzerland. Its office is at economiesuisse, the Swiss Business Federation. Members include international trading companies in particular, international or specialized law firms, chambers of commerce as well as major economic associations.

ICC Switzerland was founded in 1922 by economiesuisse (formerly Vorort), the Swiss Bankers Association and the Swiss Chamber of Commerce in France as one of the first ICC national committees.

ICC Switzerland provides access for companies based in Switzerland to the activities of ICC. In Switzerland, in coordination with economiesuisse, ICC Switzerland provides the view of ICC to the Swiss Federal Administration.

## Services

- ICC Switzerland exclusively appoints Swiss delegates to ICC organs and Commissions and coordinates their work
- ICC Switzerland, in coordination with economiesuisse, voices the views of Swiss Business in global discussions
- ICC Switzerland hosts events on topics within the global activities of ICC
- ICC Switzerland is the official distributor for ICC publications in Switzerland, for example the well-known Incoterms
- ICC Switzerland runs the secretariat of the Swiss Commission on Arbitration and ADR which proposes Swiss arbitrators in ICC procedures at the International Court of Arbitration
- ICC Switzerland hosts the Focal Point for the UN Global Compact Network Switzerland
